At the meeting of the Board of Directors of the registrant held today, 30 July 2010, the Board approved the declaration of cash dividend equivalent to P 0.03 per share payable to all common stockholders of record as of August 27, 2010 to be paid on September 22, 2010, another cash dividend of P 0.03 per share payable to all common stockholders of record as of November 26, 2010 to be paid on December 22, 2010 and another cash dividend of P 0.02 per share payable to all common stockholders of record as of January 28, 2011 to be paid on February 23, 2011.

In addition to the approval of the cash dividend declaration aforementioned, the Board, in the same meeting approved the distribution of cash bonus to all of the directors in the amount of Pesos: One Hundred Fifty Thousand (P150,000.00) each in view of the registrant's relatively favorable performance in the previous year.
