**Item 4. Resignation, Removal or Election of Registrant's Director or Officers**

At the meeting held today, July 6, 2010, The Board of Directors elected Mr. Reynaldo P. Bantug as President of Leisure & Resorts World Corporation (LRWC) and its subsidiaries, to fill up the vacancy of the office due to the resignation of Mr. Alfredo Abelardo B. Benitez last June 25, 2010. Mr. Benitez resigned as President upon his election as representative of the 3rd District of Negros Occidental to Congress.

Mr. Bantug is an incumbent independent director of LRWC since 2002. Upon his election as President of LRWC and its subsidiaries, he ceases to qualify as an independent director of the Corporation. With this change, LRWC still has two (2) independent directors remaining on its board, namely, Mr. Willy N. Ocier and Mr. Anthony L. Almeda which complies with the number of required independent director under the Code of Corporate Governance approved by the Securities & Exchange Commission.

Aside from his directorship in the Corporation, Mr. Bantug, age 60, also hold directorships in the following companies. AB Leisure Exponent, Inc., Bacolod Real Estate Development (Vice Chairman) BAPA Realty Development Corp. and BAPA Holding & Management Corporation (President).
