

At the meeting of the Board of Directors of the registrant held today, 29 July 2011, the Board approved the declaration of cash dividend equivalent to <u>P 0.03</u> per share payable to all common stockholders of record as of <u>September 28, 2011</u> to be paid on <u>October 21, 2011</u>, another cash dividend of <u>P 0.025</u> per share payable to all common stockholders of record as of <u>January 30, 2012</u> to be paid on <u>February 22, 2012</u> and another cash dividend of <u>P 0.02</u> per share payable to all common stockholders of <u>February 29, 2012</u> to be paid on <u>March 23, 2012</u>.

In addition to the approval of the cash dividend declaration aforementioned, the Board, in the same meeting approved the distribution of cash bonus to all of the directors in the amount of Pesos: Two Hundred Thousand (P200,000.00) each in view of the registrant's relatively favorable performance in the previous year.
