Belle and PLAI previously entered into an agreement with the Company and ABLGI for the operation of the casino complex. Belle and PLAI had since agreed to take in a foreign partner to further enhance the value of the project. With the entry of a foreign partner, it was agreed that LRWC and ABLGI will assist Belle in funding its own capital requirements in exchange for a share in the economic benefits to be derived by Belle and PLAI in the casino operation.

In view of the foregoing, may we request for a trading halt of LRWC shares from 9:00 am to 10:00 am on Friday, 06 July 2012.

Given the foregoing request of the Company, the Exchange will implement a trading halt on LR shares today, July 6, 2012, which will commence at 9:00 a.m. and will be lifted at 10:00 a.m.
