#### **Clarification of News Report**

We reply to your request for clarification on a news article entitled "Group eyes casino resort in Boracay" posted at the Inquirer.net on 12 December 2017. The article reported in part that:

"Gaming firm Leisure and Resorts World Corp. (LRWC) is in talks with Hong Kong-listed Galaxy Entertainment Group Ltd. (GEG), one of the three original gaming concessionaires in Macau, to build a world-class integrated beach resort and casino on Boracay island.

The project is estimated to cost between \$300 million and \$500 million, according to LRWC director Willy Ocier.

Ocier said the prospective casino-resort on Boracay Island would be located somewhere 'facing east.'

We would like to clarify that AB Leisure Global, Inc., a wholly-owned subsidiary of the company, is currently in discussion with Radiant Charm Investments Limited, a member of the Galaxy Entertainment Group, to develop a resort with casino in Boracay.

#### **Other Relevant Information**

We amend the previous submission because Radiant Charm Investment Limited (RCIL) is a member of Galaxy Entertainment Group (GEG) and it is not a direct subsidiary.
